## Rental Terms & Conditions for 2017 Season

### 1. General Conditions

Camper vehicle can be rent by legal entity or by individual, where driver must be at least 30 years old and be in a status of active driver with B category at least 5 years. Driver license validity must be at least long as rental period. Tenant is responsible for accomplish this conditions. Camper can be drive only by person named in concluded contract.

Sublease of camper is prohibited.

Smoking and any animals keeping in the camper is not allowed. Camper cannot be use in any illegal actions, criminal or fraud, customs and other offenses, drivers training, for paid transport of goods and services and transport of persons, to tow other vehicles, sports competitions, for the transportation of flammable and explosive materials as well as transport of materials strong and unpleasant odor.

Disrespect of above listed conditions, can be charged EUR 200 due the camper returning.

Rental Extension is possible only with lessor accordance.

Beginning of the rental period, start by signing a contract by both contractual sides and when whole amount of rental and deposit is paid. End of rental period is when representatives of both contractual sides sign the delivery record, payment of any additional costs, and returning deposits.

In case of any problems, traffic accidents, failures on the road and the alike, the lessee is obliged to immediately inform the lessor, together to solve the resulting problem. In case of accident, lessee is obligated to always call the police, fill in the appropriate documents, provide the record of the police, Alcohol test record, and photos of events, details of witnesses and so on.

Each case of damage or theft of the vehicle, the lessee is required to report to the Police authorities, otherwise paid the full amount of damage - the value of vehicles, regardless of insurance. Insurance does not cover the following defects, which he is obliged to compensate the lessee, if the same occurred during the lease:

- ✓ damage to tires, wheels and under body outside of a registered accident;
- ✓ damage was caused due to driving under the influence of alcohol, drugs, etc.
- ✓ damage that made by driver who is not included in the lease agreement.

Rental of campers is done according to the seasons:

- ✓ **Low season:** 31.01. – 15.04.
- ✓ **Medium season:** 16.04. – 30.06.
- ✓ **Top season:** 01.07. – 15.09.
- ✓ **Low season:** 16.09. – 22.12.
- ✓ **Medium season:** 23.12. – 30.01.

At the time of Top season rental campers is not possible less than 14 days, nor is it possible to rent for the weekend.

At the time of Medium season rental campers is not possible in less than 7 days.

The period of rest of the year, rent campers is not possible for a period of less than 4 days.

### Rental price

Prices are shown within included Price List for the 2017 Season, available on the Etno kamp web site.

All prices are including VAT, kilometers are limited to 350 km per day, and for the weekend, 750 km. If some extra miles is made, it should be paid 0,25 EUR / Km.

Minimum rental time is 4 days. To rent a camper for a longer period, for the rest of the year, the price can be contracted separately.

Price includes:

- ✓ mandatory car insurance by 1% deductible franchise covered by the lessee in the case of guilt lessee
- ✓ full risk insurance
- ✓ WC fluid, 2 gas bottles, full tank of clean water, waste water tank empty and clean cassette toilet
- ✓ air conditioning in the cabin and radio with CD player
- ✓ cover, water hose 15m, power cord, the cover for windscreen.

**PRICE DO NOT INCLUDE** – fuel, tools

### 2. Payment method and deposit

Advance payment of 30% of rent is to be paid as confirmation of booking, due the reservation. The rest must be paid 7 days prior to taking the vehicle, or 15 days before it in High season.

When booking, a potential lessee fills and Questionnaire, which is an integral part of the documentation and On line booking procedures.

In case of cancellation of the lease up to 21 days before taking the vehicle retains 30% of the advance.

In case of cancellation of the lease up to 14 days prior to taking the vehicle retains 50% of the advance.

In case of cancellation of the lease up to 7 days before taking the vehicle retains the 75% advance

With the advance payment, lessee confirms that he is familiar with the terms of the lease in full.

In the case when full amount of rent is paid and the same is canceled 2-6 days prior to taking the vehicle, retains 50% of the rent, if cancellation occurs the day before or the day of the lease, retains 80% of the lease. When receiving the payment, the lessee is required to submit a self-declaration that he is completely familiar with the terms of the lease and that it is fully accepted.

When taking the vehicle, the lessee deposited the amount of EUR 1000 as a deposit to return the vehicle in good condition, as it was taken. The deposit covers the expenses of insurance in case of accidents, damage and defects of the vehicle caused the lessee fault. The deposit should be paid when campers are taken for rent.

With his signature, the lessor confirms to tenant that he received the deposit and issuing a proper document.

### 3. Delivery and returns the vehicle

Start of the lease begins by signing the Agreement by both parties, payment of the entire amount of rent and guarantee. By signing the agreement, both sides confirmed that the vehicle is technically correct, with all the equipment and documents. List of equipment, including any small defects are listed in the technical part of the Treaty what is handover protocol.

The lessor deliver to rent a pure technically correct motorhome with a full fuel tank, full tank with clean water, with 2 full gas bottles, chemicals for the toilet, running the tank for waste water and clean cassette toilet.

Lease ends with the signature of the Minutes of the delivery, the payment of any additional costs, repayment of the deposit if it does not there are obstacles (traffic violations, defects in or on the vehicle, delays, careless use and alike.).

For cleaning and storage of vehicles for hire accounted for 100 Euro to be paid by the lessee.

The Lessee is required to return the camper in good condition and with a full tank of fuel. Otherwise, the owner will charge extra costs that will have the supplementary works.

Tenant is not required to clean a camper.

For damage to the vehicle or equipment that is not covered by insurance, lessee undertakes to pay damages.

To fill the fuel tanks that have not been returned lots, in addition to the missing fuel will be charged an additional service from 10 EUR.

Both parties must abide by the agreed terms of delivery and return of the vehicle. Vehicle should be deliver in the period from 13h to 16h, and the lessee must return the vehicle between 9h and 11h.

In the case that the vehicle is not returned on time, overdue is calculated at a price of 25 EUR / h.

As agreed, the vehicle can be retrieved in the second period, which is charged in the amount of 50 EUR.

Vehicles are retrieved and returned to the following address: Belgrade, Jurija Gagarina 14 G – local 2.

#### **The responsibility of the Lessee**

- ✓ The Lessee shall locked the vehicle at any abandonment of campers
- ✓ The keys and the document must always have along safe
- ✓ Borrower shall be liable for all damage that has not occurred in the accident and for violation of traffic regulations and other laws
- ✓ All servicing and repairing costs without consultation with the lender are not recognized and are not allowed
- ✓ In case of guilt tenant, insurance refuses to pay damages, the lessee is required to pay all costs incurred.
- ✓ In case of damage to the vehicle from an unknown person, the lessee is obliged to report the event to the police and submit an official record of it.

#### **The responsibility of the lessor**

In the case of force majeure or non-driving or unusable vehicles, corresponding to the other, or another vehicle or the entire amount is founded. The lessor does not have any additional obligations in this case.

With the signature, lessee confirms that is fully known with this Terms and Conditions and that is fully expected.

For any disputes lenders and borrowers authorized is Court in Ruma.
